**STATEMENT**

[1] The CFMEU notified a matter to the VBIDP on 1 June 2016 concerning an alleged dispute over site allowance on a project or projects being undertaken by Lend Lease Constructions Pty Ltd at 883 and 889 Collins Street Melbourne.

[2] The notification requested an inspection by the Panel and a Conference, which occurred on 9 June 2016.

[3] Following the Conference and site inspection by the Panel (all members), together with representatives of the parties, the CFMEU undertook to consider the matter further, together with the various materials tabled by Lend Lease, and to advise the Panel by 17 June 2016 if the union wished to pursue the matter for Hearing or not.

[4] The CFMEU has subsequently advised that it requires more time to determine its position and that it will advise the Panel further by 6 July 2016.
